2. Upon the Program's request, all attendees must agree to sign and abide by the terms of any additional releases or authorizations of all activities may related to the Program.
3. The Amazing Hunt's usual practice is to take up to two group photos for recording and promotional purpose at either the beginning and/or at the end of your event. Such photos will be posted in the Program's social media including but not limited to Facebook, Instagram, etc.. If your group hereby consents to such a practice, the organizer must sign on the right for consent. If your group chooses not to do so, please leave the consent area blank.

If your group has opted for our on-site photography service, all attendees hereby consent for the Program's promotional purposes in social media including but not limited to Facebook, Instagram, etc., of all attendees' voice, language, actions, manner, likeness, name, appearance, biographical material in still pictures and/or videos (collectively, the "Likeness") contained or derived from their participation in the Program. All attendees release the Producer of the Program from any and all liability arising out of its recording or use of their Likeness and/or the Materials (including, without limitation, any claim that such use invades any right of privacy and/or publicity.)
5. All attendees must be in good physical and mental health and must self-aware to stop any activities before they become ill or injured. In addition, for any Program that may involve food and beverages, all attendees must be self-aware of their own dietary preferences and limitations to a variety of allergens that may cause harm to themselves. All attendees must accept and assume all risks of injury, illness, disease, death or other damage to themselves, to others, or to their property that arises in any way possible while participating in the Program.
6. All attendees hereby release the Program and anyone who is associated with the Program from any and all claims, actions, damages, liabilities, losses, costs and expenses of any kind (including, without limitation, legal fees) arising out of, resulting from, or by reason of, their participation in or in connection with the Program.

Intending to be legally bound, all attendees do hereby, for themselves, and their heirs, executors, administrators, and any affiliated associations, waiver, release and forever discharge any and all rights or claims for damages and contractual violations that may have or which hereafter accrue to any individual against all persons, or organizations, and legal entities affiliated with The Amazing Hunt and more particularly to the Producer and the production crew of The Amazing Hunt, individually, and a whole, for any and all damages and any contractual violations which may be sustained or suffered by any attendees in conjunction with their entry in, and/or arising out of their travel to participation in, or returning from the Program.



THE AMAZING HUNT PAYMENT AND CANCELLATION POLICY

[UPDATED ON OCTOBER 1, 2024]

- a) The Amazing Hunt must receive your deposit or full payment in cash, direct deposit, e-transfer, Paypal or cheque payable to the order of Bill Lin. There is a 4% upcharge for payments through PayPal. Do not send your payment by mail. All amounts are in Canadian Dollars.
- b) The Amazing Hunt reserves the right to ask you to provide 50% of the full payment as a deposit based on your group size. All deposits are non-refundable. Advance Payment will receive a 5% discount when you provide your full payment along with your non-refundable deposit. Additional terms and conditions may apply to any discount.
- c) If your remaining balance is not paid after your Group Booking is completed, a 5% late fee will be added immediately and compounded every 10 days. The Amazing Hunt also reserves the right to refuse service if the remaining balance is not provided 24 hours prior to your Group Booking.
- d) There will be no changes to the number of attendees 24 hours prior to your Group Booking. The organizer must pay the full balance of the invoice even if there are no shows in your Group Booking. However, if there are any last-minute additions, the organizer must notify The Amazing Hunt 24 hours prior to your Group Booking and The Amazing Hunt also reserves the right to adjust the invoice based on the additional number of attendees.
- e) The Amazing Hunt reserves the right to adjust the cost per person rate or to waive any discount in its sole discretion if there are any changes to the number of attendees.
- f) Your Group Booking may be postponed to another date if the original date does not work for your group. The postponement must be done 10 days prior to the original date. The new date must be within the same calendar year as the original date. If any date change does not follow the above-mentioned conditions, your payment will become non-refundable under any circumstances.
- g) The Amazing Hunt strives to provide better experiences and values your enthusiasm.
